Please note that this contract pertains to the puppy/dog whose registration number and information is listed above under "Puppy Information". In this contract, the "buyer" is the person whose name and information is listed under "Buyer Information". In this contract, the "seller" is the person whose name and information is listed under "Seller Information".

By signing this contract, I, the buyer agree to spay/neuter the said puppy at 18 months of age and no sooner than 18 months of age.

I, the buyer, agree to provide the said puppy/dog with a humane and healthy indoor environment. I, the buyer, agree to provide the puppy/dog with proper food, shelter, shots, worming, and veterinary care throughout the puppy's lifetime. I, the buyer, agree to never abuse or neglect the said puppy/dog.

I, the buyer, agree to inform the seller of any address and/or phone number changes, so that the seller may always stay in contact with the buyer.

I, the buyer, agree that if I cannot keep the said puppy/dog for any reason, at any age, the puppy will be returned to the seller, at no cost to the seller. The seller may also choose to allow you, the buyer, to place the puppy/dog in a home approved by the seller but only if the seller approves, and only if a written letter of consent is provided by the seller, to the buyer. The puppy shall never, for any reason, be put in an animal shelter, sold to a puppy broker, or sold to a puppy mill.

I, the buyer, agree that if I do not follow the terms and conditions of this contract, I, the buyer will return the said puppy/dog to the seller, at no cost to the seller.

In the event of a breach of this contract/agreement, by the BUYER, the buyer agrees to return the puppy/dog to the seller or seller reserves the right to repossess the said puppy/dog either with or without taking legal action against the buyer, and buyer pays an additional \$1,000 plus any court fees arising.

It is mutually understood by both parties (buyer and seller) that this contract/agreement shall be governed by the law of the State of Florida. The parties agree that any action relating to this contract shall be instated and prosecuted in the courts of the County of Walton, state of Florida, and each party waives the right to change venue.
